<u>Update from BC Housing - All Strata General Meetings can be held by</u> <u>electronic means - no bylaw required</u>

BC Housing has created guidelines and orders intended to provide assistance to strata corporations during the provincially declared public health emergency related to COVID-19.

Most recent and most notable is the order made this week that (despite any provision of the Act or any bylaw or regulation to the contrary) any strata meeting may be held by telephone or by electronic means; as long as the participants can all communicate with each other during the meeting. That special authorization ends when the provincial public health emergency concludes (without being extended). However, a bylaw which allows electronic meetings for general meetings can be passed during a meeting held under this order; to preserve that flexibility and help keep owners safe after the emergency formally expires. Our new electronic meeting template accounts for these changing circumstances.
